



Meeting Immediate Needs Grant

Purpose:

The “Meeting Immediate Needs” grant is to help the Tāmariki of Ngāti Rehua-Ngātiwai ki Aotea descent or be of Maori descent and currently residing on Aotea. To assist whanau affected by the COVID-19 Delta lockdown in the Tāmaki Makaurau region to meet immediate and urgent needs such as meeting basic needs (e.g. food, water, shelter, warmth), educational support to enable re- engagement in learning (e.g. devices; connectivity; stationery; uniform; exam fees and extra-curricular activities), transportation or other expenses so they can re-engage in learning.

Grant Information:

Subject to the availability of funds:

- Approved grants will be paid up to \$250 per Primary School applicant and \$500 per Secondary School applicant. Applications will be assessed on a needs basis.
- Priority will be given to those of Ngāti Rehua- Ngātiwai ki Aotea descent currently residing on Aotea.

Conditions for Receiving Grant:

All of the following conditions must be met before a grant is approved:

- Applicant must normally reside in the Tāmaki Makaurau region and be able to provide proof of school enrolment at Primary or Secondary level (including home school) within Tāmaki Makaurau.
- At least one parent must be registered with the Ngāti Rehua- Ngātiwai ki Aotea Trust (NR-NWKA) or be of Maori descent and currently residing on Aotea.
- Provide the trust with a short 20-30 second video about “Why education is important to me?”. If assistance is required with this step please contact ngatirehuatrustboard@gmail.com.
- Complete application form and all required documents must be provided.
